Christoph ANTONS is Professor of Law at the Newcastle Law School, University of Newcastle, Australia. He is an Affiliated Research Fellow at the Max Planck Institute for Innovation and Competition in Munich; Senior Fellow at the Center for Development Research (ZEF), University of Bonn; and Senior Associate at the Centre for Indonesian Law, Islam and Society at the University of Melbourne. He is currently Project Leader of three Australian Research Council funded projects: 'Intangible Cultural Heritage across Borders: Law, Structures and Strategies in China and its ASEAN Neighbours; 'Building an Intellectual Property System: The Indonesian Experience' and 'Food security and the governance of local knowledge in India and Indonesia'. His latest book publications are Intellectual Property and Free Trade Agreements in the Asia-Pacific Region (Springer, 2015, coedited with Reto Hilty) and The Routledge Handbook of Asian (2017).



Irene CALBOLI is Lee Kong Chian Fellow, Visiting Professor, and Deputy Director of the Applied Research Centre for Intellectual Assets and the Law in Asia, School of Law, Singapore Management University. She is also Professor of Law at Texas A&M University School of Law, and Fellow at the Transatlantic Technology Law Forum at Stanford Law School. She is a prolific scholar, and her recent scholarship focuses on IP laws in ASEAN with a specific interest on trademarks, geographical indications, and cultural assets. She is, inter alia, an elected member of the American Law Institute

and an associate member of the Singapore Academy of Law. She serves in several leadership roles, including as member of the Council of the International Law Association (Singapore Branch), Chair-Elect of the Art Law Section of the Association of American Law Schools, and member of the Legislation and Regulation Committee of the International Trademark Association.



Julien CHAISSE is an award-winning specialist in international economic law with particular expertise in international economic law. Professor Chaisse is also a member of the ICANN Working Group that is conducting a Policy Development Process (PDP) to Review All Rights Protection Mechanisms in All Generic Top-Level Domains (gTLDs). Before joining the CUHK Law Faculty in 2009, Prof. Chaisse served in the Ministry of Foreign Affairs of France, and started his academic career in Europe. Since then, Prof. Chaisse is frequently invited as a guest lecturer to many academies and universities around the world, including the Academy of International Investment and Trade Law, Columbia University, Brown University and Boston University (U.S.), Passau University (Germany) and Melbourne University (Australia) where he is a Senior Fellow to the Law School.



Wan-Tsui CHIANG joined the National Chiao Tung University (Taiwan) school of law faculty in 2012. She teaches and writes on patent law, health law, and torts, with a special emphasis on medical patent and public health law. Her research examines the development of pharmaceutical intellectual property protection in Taiwan. She has also written papers on the legal issues of public

health surveillance in Taiwan. In addition to her SJD degree from Indiana University Maurer School of Law, she holds an M.A. in Humanities in Medicine from Taipei Medical University, an LL.M from University of Washington School of Law and LL.B from National Taiwan University.



Bryan DRUZIN is a specialist in legal theory. His scholarship applies game theory and behavioral economics to law and political theory. Dr. Druzin has published extensively with leading U.S. law schools (Duke, Cornell, Northwestern, University of Pennsylvania, Georgetown, etc.), top international peer-reviewed journals, and has contributed to several edited volumes published by Oxford University Press and Cambridge University Press. Dr. Druzin holds a B.A., LL.B., and LL.M. from the University of British Columbia and a PhD in law from King's College London. He teaches jurisprudence and contract law, and has previously taught at Brunel University and King's College London. Dr. Druzin is Director of the Faculty's LLM Common Law Dr. Druzin's scholarship relates to a single, defining idea: the bottom-up emergence of legal order. This topic cuts across a broad range of legal domains. His work thus addresses some of the most pressing issues of modern legal theory, such as the self-ordering potential of private law, treaty stability in public international law, the emergence of global governance, the growing power of soft law, spontaneous changes in mass social norms, and the self-ordering nature of customary law, rights, and markets. Dr. Druzin's work is highly interdisciplinary. It draws from economics, normative ethics, and the study of complex systems.



Liyu HAN is currently a Professor of Law at Renmin University of China Law School, and Director of Research Center for WTO Law of Renmin University of China, teaching International Economic Law, WTO Law, International Trade Law, International Finance Law and Commercial Arbitration. His research interests focus on trade law and trade-related issues. Prof. HAN has published many books and articles in Chinese and English, including *Protection of Industries in the context of WTO Rules, Let Bygones Be Bygones: The WTO Dispute Settlement Mechanism, Merger Control Remedies, US Foreign Trade Law* and series of WTO Cases and Analyses. Prof. HAN got his Doctor, LLM and LLB at Renmin University of China and got Postgraduate Diploma in Common Law at The University of Hong Kong. Prof. HAN visited several universities and institutions in America and Europe as a visiting scholar. Prof. Han is also Vice President of China Law Society WTO Law, Vice President of Chinese Society of International Economic law, Member of Consultant Committee of Customs Tariff Commission of the State Council, Member of Member of Expert Advisory Committee of State Council Antimonopoly Commission, and on the Indicative List of Panelist, WTO DSB.



Ching-Wen HSUEH is an Assistant Professor at National Chengchi University, department of international Business. In 2012-2016, She was assistant professor at National Chiao-Tung University, School of Law. She served an assistant professor at Graduate Institute of Financial and Economic, Feng Chia University in 2012. In 2011, she worked for Institutum Iurisprudentiae, Academia Sinica as a post-doc researcher. During her study in Germany, she did the internship at Legal Division, World Trade Organization. She received scholarship of Ministry of Education, Taiwan and scholarship of University of Cologne for International Doctoral Candidate, Germany. She

earned her Dr. iur. from School of Law, University of Cologne in 2011. Her doctoral dissertation "Direct Effect of the WTO Agreements: Practices and Grounds" was published in 2012.



Tomoko ISHIKAWA is Associate Professor at Nagoya University in Japan. She is a member of the ICSID Panel of Conciliators, appointed by the Chairman of the ICSID Administrative Council, and a member of the Legal Advisory Committee of the Energy Charter Treaty. Her professional experiences include serving as a Judge at Tokyo District Court and holding the position of Deputy Director at the International Legal Affairs Bureau of the Ministry of Foreign Affairs of Japan, where she worked on bilateral/trilateral investment treaties, Free Trade Agreements and WTO dispute settlement. Her recent publications include: Case Comment: Marco Gavazzi and Stefano Gavazzi v. Romania - A New Approach to Determining Jurisdiction over Counterclaims in ICSID Arbitration? ICSID Review (2017, forthcoming); Restitution as a 'Second Chance' for Investor-State Relations: Restitution and Monetary Damages as Sequential Options, 3 McGill Journal of Dispute Resolution (2016-2017) and Provisional Application of Treaties at the Crossroads between International and Domestic Law, 31(2) ICSID Review (2016).



Kung-Chung LIU holds LL.B. and LL.M. from National Taiwan University and a Doctorate from the Ludwig Maximilian Universitaet (University of Munich). He was a Research Fellow at Academia Sinica, Taiwan until 2017. In 2003, he was a Visiting Professor at the Faculty of Law of the National University of Singapore and Visiting Senior Research Fellow for the IP Academy of Singapore. Professor Liu has served as one of the founding Commissioners of the National Communications

Commission in Taiwan between 2006 and 2007. In 2014-15, he was a Visiting Professor at the School of Law, Singapore Management University, and the Founding Director of the Applied Research Centre for Intellectual Assets and the Law in Asia (ARCIALA). In addition, he has been coappointed Professor at the Renmin University, China (2017), and the Graduate Institute of Technology, Innovation & Intellectual Property Management, National Chengchi University, Taiwan (since 2010).



David LLEWELYN is Deputy Dean and Professor (Practice) in the School of Law, Singapore Management University and Professor of Intellectual Property Law, King's College London. He is joint author of Kerly's Law of Trade Marks and Trade Names (15th ed supplement, 2014) and Cornish, Llewelyn & Aplin, Intellectual Property: Patents, Copyright, Trade Marks & Allied Rights (8th ed., 2013), and his business book Invisible Gold in Asia: Creating Wealth through Intellectual Property was published in 2010. David is Senior Advisor at local commercial law firm Acton Law LLC. Before moving to live in Singapore in 2010, as well as teaching on the London LLM since 1982, he practiced as a solicitor in London for more than 25 years after qualifying with Linklaters and was the partner heading the IP/IT practice at White & Case in London from 1999 to 2010. From 2005 to 2007, David was Director of the IP Academy Singapore and between 2007 and 2012, its Deputy Chairman and External Director.



Flavia MARISI is a Research Assistant at the Faculty of Law of the Chinese University of Hong Kong, while completing her Ph.D. thesis at Ghent University about Environmental interests in Investment

Arbitration. Italian-qualified lawyer since 2014, she worked at the Court of Justice of the European Union, the European Commission, Law Firms, and an environmental NGO. She teaches International Investment Law and Practice at the Chinese University of Hong Kong, and Comparative Civil Procedure both at the University of Milan Bicocca, since 2011, and the University of Milan, since 2016, where she graduated with 110/110 Summa cum Laude. She specialised in EU Law with an LL.M. at the College of Europe, Bruges, and was visiting scholar at the University of California, Berkeley, University of Nice Sophia Antipolis, Sheffield Hallam University, and Tsinghua University in Beijing.



Mahdev MOHAN is an Assistant Professor of Law at the Singapore Management University, where he teaches public international law. A former Fulbright Scholar and Bellagio Center Academic Fellow, he is a council member of the Singapore Branch of the International Law Association. He is on the editorial boards of the Journal of East Asia and International Law, and the China and WTO Review. He writes and advises on public international law, investment arbitration, and human rights. Mahdev's research has been awarded Stanford University's Carl Mason Franklin Jr. Prize for International Law. He is also a Nominated Member of Parliament, and a Consultant with Providence Law Asia.



Wee Loon NG-LOY's main research interests lie in the field of Intellectual Property (IP) Law. She teaches "Law of Intellectual Property" which focuses on Singapore's IP regime, as well as "International Trademark Law and Policy" and "International Copyright Law and Policy." Amongst

her academic publications is the text on Law of Intellectual Property of Singapore (2nd ed, 2014). Outside of the university, her involvement in the legal landscape of Singapore includes the following: a member of the Resource Panel for Government Parliamentary Committee for Law and Home Affairs (1999-2000); a member of the Board of Directors of the Intellectual Property Office of Singapore (2000-2001); a member of the Board of Governors of the IP Academy (2007-2011); a member of the Senate of the Singapore Academy of Law (20122014); a member of Singapore's Copyright Tribunal (since 2009); a member of the Singapore Domain Name Dispute Resolution Policy Panel (since 2014); IP Adjudicator with the Intellectual Property Office of Singapore (2014).



Yogesh PAI is Assistant Professor of Law at the National Law University, Delhi. He teaches and writes on issues relating to intellectual property law and policy. He has previously worked with the South Centre in Geneva, Centad, New Delhi, and was an Assistant Professor of Law at the National Law University, Jodhpur. In 2012, Yogesh was a Visiting Scholar at the Asian law Center of the University of Washington School of Law, Seattle. He serves as legal member in an ad hoc committee constituted by the government of India to assess the granting of compulsory licenses for affordable healthcare in India. Previously, he was part of an ad hoc expert committee formed to examine the need for utility models in India. Since 2014, Yogesh is on the roster of WTO consultants for Regional Trade Policy Courses. Yogesh is interested in reforms in Indian legal education.



Shin-Yi PENG is a Professor of Law at National Tsing Hua University (NTHU) and the Associate Dean of NTHU's College of Technology Management. Prior to her current position, she was on secondment as Commissioner at the National Communications Commission (2012-2016). She was the Director of the Institute of Law for Science and Technology at NTHU (2007-2012). Before joining the NTHU, Professor Peng has taught the course "Legal Aspects of Doing Business with Greater China" at the J.D. program in University of Wisconsin Law School, where she received her S.J.D. degree. Member of the New York Bar, she was an intern at George, Hull, Porter & Kohli in Seattle, Washington. Her research focuses on international economic law, with a particular emphasis on trade in services. She was a Visiting Fellow at Georgetown Law's Institute of International Economic Law (IIEL) and a Visiting Professor at the Faculty of Law of Maastricht University. She is the Case Author of the 6th European Law Students' Association (ELSA) Moot Court Competition on WTO Law. Professor Peng has received a number of awards including Outstanding Research Award from the National Science Council of Taiwan. She serves in an advisory and consultative capacity to the Ministry of Economic Affairs, advising the government on trade law and policy issues. She is a member of the Indicative List of Governmental and Non-Governmental Panelists for resolving WTO disputes. She was an Executive Council member (2012-2016) and is Co-Executive Vice President of the Society of International Economic Law (SIEL).



Yaojin PENG joined the Applied Research Center for Intellectual Assets and the Law in Asia (ARCIALA), School of Law, Singapore Management University in Sept. 2017 from the faculty of Law, Maastricht University, the Netherlands, where he currently is a PhD researcher of intellectual

property law. He was previously a fellow member of the *Ius Commune* Research School, as well as a team advisor of the 17th Congress of the European Intellectual Property Institutes Network (EIPIN). He graduated in life science at University of Science and Technology Beijing (BSc) and in law at Graduate School of Chinese Academy of Social Sciences (LLM). He is a member of the Institute for Globalization and International Regulation (IGIR) at Maastricht University. Peng's current research is on intellectual property rights, particularly patents. He also has a long-standing interest in the regulation of technological research, bioethics and published several articles both in English and Chinese in IP field. In 2015, Mr. Peng was the principle investigator of *Intermediary Liability Research Project: Privacy Protection in China* funded by University of Washington and Google. The project resulted in a report and published online. His research also was funded by the State Scholarship Fund, China Scholarship Council.



Prabhash RANJAN is an Assistant Professor in the Faculty of Legal Studies, South Asian University, New Delhi. Prabhash holds a PhD in Law from King's College London where he studied on a King's College London School of Law Doctoral Scholarship. As a British Chevening scholar, he read for LLM at SOAS and UCL and graduated with a distinction. Prabhash has been a Visiting Fellow to the Lauterpacht Centre for International Law, University of Cambridge. He has been a Visiting Scholar at University of Sydney; Guest Tutor at King's College London; Research Assistant at University College London; and Research Consultant to international organisations the UNDP and UN-ESCAP. He has also advised the Indian government on bilateral investment treaties. Recently, he was part of the team at Law Commission of India that drafted the report on India's Draft 2015 Model BIT. He teaches and publishes in the area of international investment law, investment treaty arbitration and world trade law. His research has been published in ICSID Review, George Washington International Law Review, Asian Journal of International Law, Journal of World Trade, Journal of World Intellectual Property, Journal of International Arbitration and also in edited books published by OUP, Routledge and Hart Publishing.



Prashant Thikkavarapu REDDY is an Assistant Professor at the National Academy for Legal Studies & Research (NALSAR) and a visiting fellow at ARCIALA, School of Law, Singapore Management University (SMU). He studied law at the National Law School of India University (NLSIU), Bangalore and Stanford Law School, California. He has practiced as a lawyer at leading law firms in India and has also worked as an academic in India and Singapore. His primary area of scholarship is Indian intellectual property law and drug regulation law. Oxford University Press recently published his coauthored book *Create, Copy, Disrupt: India's Intellectual Property Dilemmas* on the history and politics of Indian intellectual property law.



Haochen SUN is Associate Professor of Law and Director of Law and Technology Center at the University of Hong Kong Faculty of Law. Haochen is Associate Professor of Law and Director of the Law and Technology Center at the University of Hong Kong Faculty of Law. His research and teaching focus on the theoretical and policy foundation of intellectual property, Chinese intellectual property law, and international and comparative intellectual property law. His most recent research is concerned with copyright law and the public interest, intellectual property protection of luxury goods, and intellectual property and social justice.

Haochen has twice won the HKU Faculty of Law Research Output Prize. He co-edited The Luxury Economy and Intellectual Property (Oxford University Press, 2015) with Professors Barton Beebe and Madhavi Sunder. He is currently completing a book that aims to put forth a new ethical theory of copyright and the public interest. The book will be published by Cambridge University Press in 2018. He is also co-editing The Cambridge Handbook of Copyright Limitations and Exceptions in

Comparative Perspective (Cambridge University Press, forthcoming 2018) with Professors Shyamkrishna Balganesh and Wee Loon Ng-Loy.

Haochen has been a visiting professor at the University of California, Davis, School of Law and the University of North Carolina School of Law. Before joining HKU, he worked as a research fellow at the Harvard Berkman Klein Center for Internet & Society and the Max Planck Institute for Innovation and Competition.

Haochen has given public lectures at many leading law schools in North America, Europe and Asia. He has also spoken at many international conferences. His recent work on intellectual property has been selected for presentation at the Fourth Harvard-Stanford International Junior Faculty Forum, the Plenary Session of the Eleventh Intellectual Property Scholars Conference, and the Fourth Junior Scholars in Intellectual Property Workshop at Michigan State University College of Law.

Haochen has organized many international conferences on intellectual property. He launched the HKU Lecture in Intellectual Property and the Insights in Intellectual Property Practice public lecture series in 2015 and 2016 respectively. These events have featured public lectures and talks by leading intellectual property scholars, practitioners and governmental officials. In addition, Haochen has advised leading law firms and companies in the entertainment, information technology, and luxury and fashion sectors on matters relating to intellectual property protection. His opinions about intellectual property have appeared in Forbes, The Los Angeles Times, The New York Times, South China Morning Post, Ming Pao, Shenzhen Satellite TV, and RTHK.



Benjamin THAM is an incoming Research Associate at the Applied Research Centre for Intellectual Assets and Law in Asia of the Singapore Management University. He received a BSc in Life Sciences from the National University of Singapore and a LLB from the University of Nottingham. He is also called to the Bar as an Advocate & Solicitor of the Supreme Court of Singapore. Benjamin has experience in IP law in both the public and private sectors.



Heng WANG is Associate Professor at the Faculty of Law, the University of New South Wales (UNSW Law), and co-director of UNSW Law's China International Business and Economic Law (CIBEL) Initiative. He is also university visiting professorial fellow at Southwest University Political Science and Law, China. Heng has spoken at the WTO Headquarters and many leading institutions, including Harvard University, Columbia University, Oxford University, New York University, University of Pennsylvania, University of Virginia, the LSE, and University of Paris 1. As visiting professor, he taught at leading law schools in Australia, Canada, China, Japan and the US. Heng conducted research at the WTO Secretariat, and was the Max Weber Fellow at European University Institute. Heng is or was executive council member of one global, two Asian and all three Chinese societies of international economic law.
